Dear valued customer,

Maquet Cardiopulmonary GmbH (MCP) would like to inform you with this letter about a recall for the above-mentioned Custom Tubing Packs (CTP) due to inappropriately deployed gas filters in fluid-bearing lines of the product.

The Heart-Lung-Machine (HLM) CTP is a component of an extracorporeal system and may only be used in combination with other components (e.g., blood pumps, oxygenators, hemoconcentrators, heat exchangers). It is used to transport blood and other fluids between the patient and the extracorporeal system. The HLM CTP is intended for use in extracorporeal circulation during cardiopulmonary bypass procedures.

Problem description

Maquet Cardiopulmonary GmbH became aware of the issue in course of a customer complaint. It was reported that there was gas leaking from the cardioplegia line. The customer did not replace the product during treatment. No harm to any person has been reported. Upon investigation of the complaint, it was noted that the gas filter of the HLM CTP was not deployed as specified by the manufacturer (i.e., in gas-bearing line/tube).

Hazardous situations

In course of a Health Hazard Evaluation (HHE), MCP determined the following hazardous situations for the inappropriate deployment of the gas filters:

- Patient, user or other persons are exposed to pathogenic agents.
- The patient is exposed to inappropriate low blood flow.
- Patient is exposed to inappropriately high pressure.
- Product exchange/replacement.

Potential harms

The possible immediate and/or long range health consequences of the nonconformance include the following:

- Inflammation
- Infection
- Sepsis
- Ischemia
- Hypertension
- User inconvenience

Maquet Cardiopulmonary GmbH has not identified any complaints of patient harm, serious injuries, or deaths due to failure mode described above.
