An event occurring on a radiant warmer Fabie 4300 came to our attention last July. A newborn fell from the bed placed in anti-Trendelenburg position.

Assessment has revealed that this event is linked to the two following conditions :

- Malfunction of the blocking actuator at the rear of the table, which extended under the load and didn't maintain the bedding surface in horizontal position.
- Front panel of the table left open or not properly closed by the user

According to the actuator manufacturer's analysis, the malfunction could be linked to the user(s) applying an excessive load on the actuator, without properly activating its release.

It's the first event of that sort that we know of since the product has been launched in 2006. Nevertheless, as a precaution, and to avoid any new incident, we would like to remind users of our instructions for use. Meanwhile, we are updating our control instructions during preventive maintenance.

During preventive maintenance operations (at least once a year), check the operation of the table bed incline/decline (tilt) function as follows :

CONTROL OF INCLINE/DECLINE

Operation check :

Adjust the bedding surface into tilt (incline/decline) position by holding the bed's handle with the left hand, and pulling with the right one on the knob located on the right side. Pull the knob (1) and adjust the tilt (incline/decline) without forcing (2). Release the knob to block the bed.



Bedding surface mouvement must be easy, without exerting pressure and must lock upon realeasing of the knob. If the bed doesn't tilt easily, isolate the device and call Médipréma or your dealer customer service.

Control of the actuator

Position a 5 to 10kg weight at the front of the bedding surface placed horizontally. Leave the bed with this weight on it for at least 1 hour. Check that it remained horizontal.





Bedding surface must stay in its original position. If you've noticed a shift in position, isolate the device and call Médipréma or your dealer customer service.


WARMING TABLE FABLE reference 4300 ADDITIONAL INSTRUCTIONS FOR USE

Panels handling

To fold down the panels, then rotate them outwards (2).



To close the panels, do in reverse order : rotate the slightly pull upwards (1) and panel towards the inside of the bed (1) and press it down to lock it (2)





Never leave a newborn unattended if the panels are opened or removed (risks of falling).

Check that the panels are correctly locked before leaving the baby. Make sure no object (sheets, dressings ...) prevents the panels from locking properly

Bedding surface maneuver for tilt

Adjust the bedding surface into tilt (incline/decline) position by holding the bed's handle with the left hand, and pulling with the right one on the knob located on the right side. Pull the knob (1) and adjust the tilt (incline/decline) without forcing (2). Release the knob to block the bed.





Bedding surface mouvement must be easy, without exerting pressure and must lock upon realeasing of the knob. If the bed doesn't tilt easily, isolate the device and call Médipréma or your dealer customer service.



In maximal tilted position, the child can slide. The side of the bed features provisions for retaining straps to prevent this. Using such devices or not is the responsibility of the medical staff.
