The purpose of this communication update is to inform you that additional product codes have been included in the scope of this field safety corrective action which Cardinal Health is conducting for all product codes of Kangaroo Enteral Feed Pump Sets listed in the table below due to the potential for air appearing in the enteral feed pump set tubing during set-up. The purpose of this communication is to advise you of this situation and to provide guidance to help address the issue prior to the availability of the corrected product. This is not a product removal. You are not required to return the product.
